Regular Council Meeting January 3, 2022 – 6:00 P.M. Community Media Center

Mayor Dave Goedken called the meeting to order. Council present were: Wayne Peach, Brenda Hanken, Candy Langerman, Chris Lux, Scott Brighton and Tom Yeoman. Also present were City Administrator Russell Farnum, City Clerk Sally Hinrichsen, Library Director Michelle Turnis, Police Chief Britt Smith, Park & Rec Director Jacob Oswald, Public Works Director Nick Kahler and Water/Wastewater Superintendent Jim Tjaden. The public was invited to attend the meeting in person, with limited seating or to participate in the meeting electronically via "Zoom Meetings" and were encouraged to communicate from Zoom Meeting via chat, due to the heightened public health risks of the Coronavirus Pandemic (COVID-19). The meeting did have public attendance, both in-person and via Zoom.

Yeoman moved to approve the agenda, Langerman seconded, roll call unanimous.

Lux moved the consent agenda, Langerman seconded, roll call unanimous.

Mayor Goedken opened the public hearing on the proposed Frontier Warehousing (the "Developer") and Oak Street Commercial Cabinets Inc. dba Oak Street Manufacturing Development Agreement. Staff received no written comments and there were no oral comments. Farnum reported Oak Street Manufacturing plans to build a 40,000-sf building and create 10 to 20 new jobs and have requested rebates and grants, which were agreed to a not to exceed \$325,000 over a 10-year period. The two public hearings are needed, one to approve the developer's agreement and then another to add project to the TIF plan. Mayor Goedken closed the hearing on the proposed Frontier Warehousing (the "Developer") and Oak Street Commercial Cabinets Inc. dba Oak Street Manufacturing Development Agreement. Langerman moved to approve Resolution #2022-1 To Approve Development Agreement between City of Monticello and Frontier Warehousing (the "Developer") and Oak Street Commercial Cabinets Inc. dba Oak Street Manufacturing, Brighton seconded, roll call unanimous.

Mayor Goedken opened the public hearing on the proposed designation of Amended Monticello Urban Renewal Plan to include Frontier Warehousing (the "Developer") and Oak Street Commercial Cabinets Inc. dba Oak Street Manufacturing Project. Staff received no written comments and there were no oral comments. Mayor Goedken closed the hearing on the proposed designation of Amended Monticello Urban Renewal Plan to include Frontier Warehousing (the "Developer") and Oak Street Commercial Cabinets Inc. dba Oak Street Manufacturing Project. Langerman moved to approve Resolution #2022-2 To Approve Amendment to Urban Renewal to include Development Agreement and Economic Incentives to Frontier Warehousing (the "Developer") and Oak Street Commercial Cabinets Inc. dba Oak Street Manufacturing, Lux seconded, roll call unanimous.

Yeoman moved to approve Resolution #2022-3 Designating the Monticello Express as the Official Publication Newspaper for City of Monticello, Hanken seconded, roll call unanimous.

Farnum advertised for RFP in the Monticello Express for the City owned lot located at 449 North Sycamore Street and the City must hold a hearing prior to taking action on selling the lot. Langerman moved to approve Resolution #2022-4 Scheduling a public hearing for January 17, 2022 at 6:00 PM to receive input and to preliminarily accept proposal for the purchase of 449 North Sycamore Street, Brighton seconded, roll call unanimous.

Regular Council Meeting January 3, 2022

Smith reviewed the Jones County Dispatcher's Agreement with the City cost of \$25,975.00 for FY 2023. Langerman moved to approve Resolution #2022-5 Approving Agreement for Communication Services Between Jones County, Jones County Sheriff, and City of Monticello, Brighton seconded, roll call unanimous.

Farnum reported the Council was presented the proposal from the Jones County Fair Board for various sidewalk and drainage issues at the City Park on North Maple, however, the item was not on the agenda for Council to take action. Fair Board will take bids for the improvements and let the City know their share, if the amount is more than \$5,000 it will come back to Council for approval. Brighton moved to approve Resolution #2022-6 approving sidewalk replacement and cost sharing with Great Jones County Fair, Langerman seconded, roll call unanimous.

Goedken reviewed the various Council appointments to serve as liaison for City Boards and County and Regional appointments.

Goedken would like to meet with each department head and go over their budgets and questioned if the Council would like to meet before and/or after a Council meeting, evening or Saturday to do this. Consensus of the Council was to meet at 5PM on January 17th prior to the Council meeting at 6 PM, and then again right after the meeting to see how many they can get through. If needed they will have additional meetings.

Goedken discussed various training for Council and would like to hold a goal setting meeting. Council felt mid-summer would be a good time for a goal setting session.

Farnum reported the City Attorney sent the final version of the Policy Manual. He stated the second session of MLA training with the League of Cites is this week. He reported the Airport was granted \$159,000 for future projects. Following the recent snow storm, someone hit the light pole at First and Cedar Street, which was turned into the City insurance. The 7th Street project pre-con meeting will be held this week and contractor is ready to get started.

Tjaden reported their generator is leaking and he called Althoffer to look at it. Hawkins is taking a sample of sludge to try to figure out why it has not been settling for the last two years. He also reported an employee had surgery and will be out for 8 to 10 weeks, but surgery went well.

Brighton moved to adjourn the meeting at 6:42 pm.

Synopsis: The City acquired a dilapidated property at 449 N. Sycamore, and demolished the structure with the intent of returning the property to the tax rolls.

Resolution 2021-155, approved on December 6, authorized Staff to advertise and accept proposals for the property, and scheduled a public hearing on the proposals for the January 17, 2022 Council meeting.

Background/Discussion: Based upon the December 6 direction, Staff advertised and accepted proposals for the subject lot.

Mike and Emily Kraus have submitted a proposal to purchase the property for \$20,000, with \$10,000 paid up front and \$10,000 paid upon closing on the lot. They would build a 1600 square foot, 3-bedroom ranch with an unfinished basement, within calendar year 2022. Their intent is to sell the home with a price point of the mid-200's. The only contingencies are the City would deliver clear title to the lot, and clearly identify the property pins so there is no discrepancy with the neighbors.

The City Administrator spoke with Kraus about these details, which can be outlined in a Purchase Agreement, once the proposal is approved by the Council. The Agreement would include the following terms:

- In order to ensure Kraus proceeds with the construction in a timely manner, the City would hold title to the lot until Kraus has the weathertight building shell completed, at which point closing would occur;
- Kraus would provide a Certificate of Insurance, naming the City as additional insured, in order to proceed with construction on the City property, to assure his improvements are covered in case of fire or other calamity, and to protect the City from liability;

- The City and Kraus would meet with the neighbors and agree on the lot corners prior to construction if no agreement could be reached, the City would provide a surveyor to stake the corners of the property;
- And, of course, all other typical language in a purchase contract.

Depending upon public input received at the public hearing, attorney review and Council direction, these terms may be subject to additional consideration.

<u>Recommendation:</u> Staff recommends Council approve Kraus's proposal, and direct the City Attorney to draft an appropriate purchase contract and authorize the City Administrator and City Clerk to execute all documents to proceed with this project. The attached Resolution incorporates said direction.

- In order to ensure Kraus proceeds with the construction in a timely manner, the City would hold title to the lot until Kraus has the weathertight building shell completed, at which point closing would occur;
- Kraus would provide a Certificate of Insurance, naming the City as additional
 insured, in order to proceed with construction on the City property, to assure
 his improvements are covered in case of fire or other calamity, and to protect
 the City from liability;
- The City and Kraus would meet with the neighbors and agree on the lot corners prior to construction if no agreement could be reached, the City would provide a surveyor to stake the corners of the property;

• All other typical language in a purchase contract, and

WHEREAS, The Council finds that the City Administrator and City Attorney should work with Mike and Emily Kraus to finalize details and to have a purchase agreement prepared between the City and Mike and Emily Kraus, setting out the terms outlined above, with the costs of survey, if needed and closing costs to be covered by the City, prior to transfer and closing on the property.

NOW THEREFORE BE IT RESOLVED by the City of Monticello, through its' City Council, in session this 17th day of January 2021 that the sale/transfer of the City property considered during tonight's Public Hearing is hereby approved and the City Administrator is directed to work with Mike and Emily Kraus and to proceed with the preparation of a purchase agreement consistent with this resolution, and authorized to sign any documents to execute said agreement, and the eventual property transfer and closing.

With the new census count the amount raised to \$1,212., for FY '23. For estimation purposes our receipts could be \$20,000. 4% would be an additional \$800. This investment would be paid from the Hotel/Motel Tax fund this year, like FY '22.



We would like to say how thankful we are for your continued support of our Coalition efforts. This support makes our county an even healthier and safer place to live. The partnership of so many across the county helps us sustain these outcomes for our youth. This past year continued to be very challenging for us all. Your partnership along with the other Jones County cities and the County helps us sustain good outcomes for our youth.

In the past 17 years, tremendous strides have been made in reducing youth substance use in Jones County. When the Coalition began working on underage drinking in 2004, 52% of our county's 11th graders reported binge drinking, according to the lowa Youth Survey. The IYS results released 2 years ago showed only 7% reporting binge drinking! The students did not take the survey last fall as it was delayed due to the pandemic. The youth just finished the survey last week so we will have new countywide data soon. Since 2008, when we received the Drug Free Community (DFC) grant to include the other drugs most affecting our youth, marijuana use has also gone down from 16% to 5%. Prescription drug misuse has decreased from 9% to 3%. These are not just numbers—they are our kids. These kids quickly become adults with improved family relationships and the ability to provide for their families without substance use disorders. Unfortunately, although youth tobacco smoking has gone down significantly across the country over the past two decades, youth vaping skyrocketed. Our 11th grade use increased from 10% to 23% between 2016 and 2018. Suicide ideation has also increased drastically for both our middle and high school students combined from 13% to 21% in the same years. The Coalition is prioritizing these issues more now as well.

Help us continue our youth prevention efforts. <u>Our primary source of funding we had for over 10 years ended over 2 years ago.</u> Three years ago we were fortunate to receive a smaller grant called the CARA (Comprehensive Addiction and Recovery Act) grant to focus on youth methamphetamine and continuing to focus on prescription drug misuse. <u>This ends next month</u>. We are requesting \$3000 at this time to be used to continue our work with the county's youth through our youth advisory committee, BEASTS (Being Excellent and Staying Totally Safe). This group not only advises the Coalition on trends and ideas on what actions to take to meet the needs of youth, but they also create marketing campaigns for youth and participate in many other coalition activities. We also assist the student advocacy group, SODA, at the Monticello High School and the groups in each of the schools. In the long run, the preventative work of the Coalition saves money in our communities.


THE ISSUE

In response to tragedies and overwhelmingly high rates of underage drinking, the Jones County school districts began a project in 2004 that included community efforts to reduce underage drinking through coalition work.

Those efforts became the "Jones County Safe and Healthy Youth Coalition." In 2008 when the Drug Free Community grant was received, the Coalition expanded its focus beyond alcohol to include marijuana, nicotine, and Rx drug misuse. In 2018, youth meth use was added when another grant was received.

A few of our accomplishments...

- The Iowa Youth Survey (IYS) shows that from 2002 to 2018, reported binge drinking among Jones County 11th graders dropped 45 percentage points (52% down to 7%)!
 Marijuana use, since 2008, has also gone down 11 percentage points (16% to 5%)
 See chart below.
- The IYS shows from 2008 to 2018, reported tobacco use among 11th graders is down 18 percentage points (from 27% to 9%). Vaping has recently become a great concern though. Prescription drug misuse decreased from 6% to 3%.
- Education and advocacy for youth to County officials aiding in the passage of the Social Host Ordinance and the Underage Consumption Ordinance!
- Worked with Jones County Sheriff's Department to implement Responsible Beverage Service Training (TIPs), quarterly for "On" and "Off Premise" Businesses (Bars and Stores). Many communities have adopted a Responsible Beverage Service ordinance.
- Worked with Monticello and Anamosa Police Departments to support, coordinate and increase alcohol compliance checks and compliance rates in Jones Co.

In March of 2019, the Jones County Drug Free Community Grant ended. Unless we can continue to secure local support through existing and new county partnerships, the gains we have seen in our county will be threatened. The Coalition is the only entity of adults and youth working on this issue looking at changing the culture/environment related to substance abuse.

Employee marijuana use is associated with more absences, tardiness, accidents, workers' comp claims & turnover. Those testing positive for marijuana had 55% more accidents, 85% more injuries & 75% more absenteeism. 2015 National Institute on Drug Abuse, NIH, Research Report Series

We need to see an increase in an employable workforce by continuing the work of reducing substance abuse in Jones County!



Synopsis: Mayor Goedken asked that the Council discuss the extension of sidewalk or a trail on North First Street, from Business 151 to Willow Trail at Kitty Creek.



The improvement would connect Willow Trail to downtown.

The City Engineer is estimating the cost of this improvement for inclusion in the budget and we hope to have that number soon. For comparison, if we were replacing existing 4 foot wide, 4" thick concrete sidewalk, the cost would be about \$40,000. If we propose a 6 foot wide, 6" thick sidewalk (with excavation and new base, due to being new construction) this improvement will probably exceed \$80,000.

<u>Recommendation:</u> Council direction on the priority of this project, and inclusion in the FY22/23 budget, is requested.
