#### RESOLUTION NO. 2025-110

Resolution to fix a date for a public hearing on proposal to enter into a General Fund Equipment Financing Agreement with payments thereunder in an amount not to exceed \$75,000

WHEREAS, pursuant to the provisions of Section 364.4 of the Code of Iowa, the City of Monticello (the "City"), in Jones County, State of Iowa proposes to contract indebtedness and enter into a General Fund Equipment Lease/Loan Agreement (the "Financing Agreement") with payments thereunder in an amount not to exceed \$75,000, for the purpose of acquiring camera equipment for use by the municipal police department, and it is necessary to fix a date of meeting of the City Council at which it is proposed to take action to enter into the Financing Agreement and to give notice thereof as required by such law;

NOW, THEREFORE, Be It Resolved by the City Council of the City of Monticello, Iowa, as follows:

- Section 1. The City Council shall meet on August 18, 2025, at the Monticello Renaissance Center, Monticello, Iowa, at 6:00 p.m., at which time and place a hearing will be held and proceedings will be instituted and action taken to enter into the Financing Agreement.
- Section 2. The City Clerk is hereby directed to give notice of the proposed action on the Financing Agreement setting forth the amount and purpose thereof, the time when and place where the said meeting will be held by publication at least once, not less than four (4) and not more than twenty (20) days before the date of said meeting, in a legal newspaper which has a general circulation in the City. The notice shall be in substantially the following form:

# NOTICE OF PROPOSED ACTION TO INSTITUTE PROCEEDINGS TO ENTER INTO A GENERAL FUND LEASE/LOAN AGREEMENT WITH PAYMENTS THEREUNDER IN AN AMOUNT NOT TO EXCEED \$75,000

### (GENERAL FUND)

The City Council of the City of Monticello, Iowa, will meet on August 18, 2025, at the Monticello Renaissance Center, in the City, at 6:00 p.m., for the purpose of instituting proceedings and taking action to enter into a Lease/Loan Agreement (the "Financing Agreement") with payments thereunder in an amount not to exceed \$75,000 for the purpose of acquiring camera equipment for use by the municipal police department.

The Financing Agreement is proposed to be entered into pursuant to authority contained in Section 364.4 of the Code of Iowa and will constitute a general liability of the City, provided, however, that payments under the Financing Agreement shall be payable from the City's General Fund and not from the direct imposition of a debt service property tax levy.

At the aforementioned time and place, oral or written objections may be filed or made to the proposal to enter into the Financing Agreement. After receiving objections, the City may determine to enter into the Financing Agreement, in which case, the decision will be final unless appealed to the District Court within fifteen (15) days thereafter.
